Request for Proposal for Operation and Maintenance of Multi-Level Car Parking at Sectors – 16A and 38A, Noida

NOIDA has constructed **Multi-Level Car Parking at Sectors – 16A and 38A, Noida** for the convenience of the public. In this regard, the Authority now invites E-bids for **Operation and Maintenance of Multi-Level Car Parking at Sectors – 16A and 38A, Noida** for a tenure of 1 (one) year further extendable by a period of 1-year basis performance review.

The bidder should fulfill the following minimum technical and financial criteria:

- a. Sole proprietorship, registered partnership firm, public limited company, private limited company, LLP can submit the Bidder. The firms and the companies should be registered in India.
- b. The Bidder should have experience of minimum 2 (two) years from the date of registration for providing manpower services. The Bidder should have completed, during last 2 (two) years (period ending last day of month previous to the one in which the bids are invited) should be either of the following:
 - i. One assignment of similar work of value not less than **INR 1.18 Crore (Rupees One Crore Eighteen Lakh only)**

Or
 - ii. Two assignments of similar work of value not less than **INR 88 Lakh (Rupees Eighty-Eight Lakh only) each**

Or
 - iii. Three assignments of similar work of value not less than **INR 59 Lakh (Rupees Fifty-Nine Lakh only) each**

Definition of Similar Works supply of resources to Government Departments/ Public Sector/ 5&4-star Hotel/ Hospital/ Municipal Corporation/ Airport/ Sea Port/ Railways/ Bus Terminals/ Office complexes etc.

- c. The Bidder should have minimum average annual turnover of **INR 44 Lakh (Rupees Forty-Four Lakh only)** in the last 3 (three) Financial Years (2016-17, 2017- 2018, 2018-19) preceding the Bid Due Date.
- d. The Bidder should be registered with Labour Department for supply of manpower.
- e. The Bidder must have at least 120 personnel and it should be registered with appropriate authorities under Employees Provident Fund and Employees State Insurance Acts in India.
- f. The Bidder must have either the Registered Office or the functional Branch Office located in Delhi NCR.
- g. The Bidder should be registered with the Goods and Services Tax Authorities.

The terms and conditions along with eligibility and evaluation criteria have been detailed in the tender document. The interested applicant can obtain the RFPs.
