CONDITIONS OF WORKING OF EMPANELLED PARTICIPANTS

1. The empanelment is valid for a period of 02 (TWO) years from the date of issuance of this letter. The same may be extended with the approval of the Chief Executive Officer, NOIDA as per requirement of the ongoing projects.
 2. During the empanelment period, as and when NOIDA, requires any assistance for carrying out a project, the empanelled DESIGNERS/ DESIGNER FIRMS/ CONTRACTORS may be engaged as per procedure to be adopted and intimated in advance by Noida Authority.
 3. The NOIDA Authority makes no commitments, express or implied, that this process will result in guaranteed award of any consultancy assignment, as a result of this empanelment. The Authority, on its discretion, reserves the right to extend or discontinue the engagement at any time without assigning any reasons and shall not be liable to pay any compensation on this account. This empanelment would not, in any way, mean that the Authority would be paying any retainer-ship fee or monthly consultancy charges or any other form of remuneration to the empanelled Designers/Designer Firms/ Agency / Contractor
 4. The empanelled consultant shall not utilize or publish or disclose any statistics/ data/ proceedings/ information collected during discharge of his function, without a written consent from the Authority in this regard. The Consultant shall be duty bound to hand over the entire record of assignment to the Authority before the expiry of the contract. The Authority will retain the absolute copyright of all such records, including but not limited to rights for adaptation/ translation/ preparation/ production/reproduction/ alteration/ archiving and such documentation could be used in any future programmes of the Authority, as it may consider appropriate.
 5. The empanelment will be discontinued if the empanelled agency fails to adhere to the Terms & Conditions of engagement, or to execute a contract, or has executed unsatisfactorily. The decision of Chief Executive Officer, Noida Authority shall be considered final in this regard and dispute will be settled under the jurisdiction of District court, Gautam Budh Nagar, UP.
