Eligibility for participation:

- Government Oil companies, Private Oil Companies authorized by Government of India for establishment of Petrol Pumps, Individual LOI holders (Letter of Intent) will be eligible to participate in the E-Auction. Private Oil Companies will be required to produce authorized certificate issued by Ministry of Petroleum and Natural Gas Government of India/ Authorize Statutory Bodies of GOI attested copy of license along with the E-Auction form.
- LOI holders will be required to produce a valid attested copy of Letter of Intent from Oils companies along with the E-Auction form. Expired, Invalid and LOI's applied (which will be issued in future) will not be considered for participation in E-Auction process.
- In case of E-Auction Bid on behalf of a Pvt./Public Ltd. Company, resolution duly signed and attested, authorizing the E-Auction Bidder to submit E-Auction Bid on behalf of the company, is to be enclosed along with E-Auction Bid form along with List of Director(s)/ Shareholder(s) /Partnership

Firm/Individual duly attested by Chartered Accountant is required to be submitted.

How to Participate:

- Interested parties will need to register and obtain user ID and password on the portal <https://property.enter.sbi> and thereafter deposit non-refundable and non-adjustable E-Brochure document fees of Rs. 5,000/- + 18% GST and non-refundable and non-adjustable Processing Fees of Rs. 20,000/- + 18% GST and earnest money (EMD) Rs. 5,00,000/- for separately against each property for participation in the E-Auction through online payment on or before 07-10-2022 by 5.00pm. NOIDA will not be responsible for any payment after that and E-Auction Bid will not be considered.

It will be the sole responsibility of the E-Auction Bidder/Participant to obtain a compatible computer terminal with internet connection to enable him/ her to participate in E-bidding process any reasons thereof. E-Auction Bidder is required to deposit a separate EMD for each advertised property.
