About Project

Eligibility of Bidders

Experienced individual having experience of management of club or similar facilities can submit the EOI. The applicant must be an Indian citizen.

Qualification of Bidders

To be eligible for qualification and short-listing, the Bidders shall have to satisfy the following conditions of eligibility

Technical Capacity

The bidder should have undertaken similar works of management of club or similar facilities.

Selection Process
