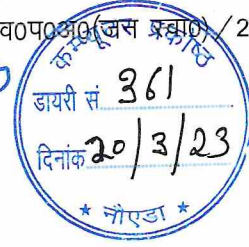

कृपया अवगत कराना है कि नौएडा क्षेत्र में Treated Water को Reuse करने के दृष्टिगत Automated Car Washing System लगाया जाना प्रस्तावित है। उक्त हेतु एजेन्सी का चयन करने के लिए दिनांक 28.02.2023 को RFP आमंत्रित की गई है। उक्त निविदा के अन्तर्गत Pre-Bid Meeting में प्राप्त हुई queries का निस्तारण के दृष्टिगत RFP की शर्तों को एवं निविदा की तिथियों को निम्नानुसार संशोधित किया जाता है।

9	Contract should be minimum 7-8 Years	Agreed for 5 Years and extendable subjected to decision of NOIDA Authority
10	Cafeteria space with service station should be permitted	The waiting lobby up to 2 tables and maximum sitting capacity of 6 persons can be developed by the successful bidder.
11	Water used in car washing have to be properly managed.	The O & M is in the scope of successful bidder. The water used in car wash have to be managed & compiled as per Central Pollution Control Board/Uttar Pradesh Pollution Control Boards guideline/rules. The Authorization/approval is also to be done by successful bidder, however the NOIDA Authority will support in documentation as and when required.
12	The location must be well connected with main road have decent parking space	As per Sr. No. 2 of the reply
13	Location- Proposed location has to be visible and nearby to the road by which people may easily reach and use the facility frequently	As per Sr. No. 2 of the reply

14	Area of land- Allocated land area has to be minimum 500 sq mtr by which we may facilitate car owner a comfortable waiting lounge along with facility of cafeteria, washrooms, charging points for their gadgets and utilize their precious waiting time all the facility in comfortable environment. 15	Recycle of wastewater- As per RFP these facilities will be installed near to existing STP plants so I would suggest to make the provision to dispose the used greasy, oily and muddy water by return drainage system to STP raw water tank by which same can be retreated properly as any treatment at facility by small ETP will not able to give good quality clean water equal to STP.	The O & M is in the scope of successful bidder. The water used in car wash have to be managed & compiled as per Central Pollution Control Board/Uttar Pradesh Pollution Control Boards guideline/rules. The Authorization/approval is also to be done by successful bidder; however, the NOIDA Authority will support in documentation as and when required.
16	Tenure of Agreement -Tenure to develop and use the facility has to be minimum 7 years with facility of renewal of agreement on successful operations during fixed tenure to recover the ROI and get rationalize revenue against operations.	As per Sr.No.3 of reply.
17	EV Charging Facility- In addition to conservation of water I would like to suggest to use this facility for green energy usage to keep our environment pollution free. So kindly allow install car recharging doc stations with ample space to park and recharge their EVs in que for washing.	As per Sr. No 7 of reply
18	Civil Construction- As facility will be given to operator for a short time period, I would suggest to develop permanent civil work like boundary wall, toilets and main gates by authority only.	As per RFP
